**Treasure's Report**

- YTD thru October 30<sup>th</sup> revenues of \$17,950 which does not include registration fees. Expenses are \$26,000. There is a negative balance at this time because some carry-over expenses were paid from last year. The expenses included field usage fees, legal fees and professional fees related to tax preparation.
- Registration checks will be processed this week (approximately \$60,000 will be deposited).
- Current money market account balance is \$45,046.
